EXPRESSION OF INTEREST

The **Orissa Livestock Resources Development Society (OLRDS), OBPI Campus, Bhubaneswar – 751003** invites offers on behalf of Director, Animal Husbandry & Veterinary Services, Orissa, from only Public sector/ Nationalized Insurance Companies, to undertake the insurance of 40,000 female Crossbred Calves booked under “Genetic Up-gradation of cattle and female crossbred calf rearing scheme” funded by RKVY in 30 Districts of Orissa, as per the guidelines issued by Government of Orissa, F&ARD department during the year 2010-11. The facility of insurance will be provided to cross-bred female calves in the event of death only. This scheme is implemented under RKVY, which provides 100% subsidy to the beneficiaries for one time insurance of an animal for a period of three years coverage. This Eoi shall remain valid for a period of 12 months from the date of acceptance without affecting the insurance coverage period. All genuine claims shall be settled within 15 days of the receipt of the relevant records / documents by the Insurance Agencies.

(A) Type of Policy Agreement: Policy will be in shape of Livestock Insurance Master Policy Agreement between OLRDS and the selected Insurance Company for a period of 12 months from the date of agreement.

(B) Scope of Agreement: As per the terms and conditions of the policy this agreement covers the various beneficiaries as identified under Calf Rearing Scheme launched by Govt. of Orissa for the identified districts of Orissa State.

(C) This agreement shall be with specific reference to: Calves-calves refer to female offspring born out of Cross-bred/Non Descriptive cow with AI with pure bred/cross-bred exotic semen
